SIRA telehealth item numbers for medical practitioners – effective 1 February 2024

This document lists the 54 telehealth item numbers for medical practitioners delivering telehealth services in the workers compensation scheme. Medical practitioners are to bill for telehealth consultations using the same AMA Fees List item number normally billed for a face to face consultation, with the addition of a 'T' as a suffix to the item number.

Please note, the following telehealth and case conference items have a nil fee (Medical services identified in the AMA List by AMA numbers AA170, AA584 – AA670, AF070 – AF180, AF260 – AF370, AJ051 – AJ200, AM210 – AM 240, and AP050 – AP278) as SIRA specific items exist for the provision of telehealth and case conferencing services as set out in column 2 of the table below.

Telehealth means delivery of consultations via video or telephone. Consultations would be inclusive of any electronic communication to support the delivery of the treatment service. No additional fee (e.g. facility fees) can be charged in relation to the consultation.

Practitioners are responsible for delivering telehealth consultations in accordance with the principles of professional conduct and the relevant professional and practice guidelines to ensure that all care is taken to ensure the safety, appropriateness and effectiveness of the service.

All medical practitioners treating workers compensation patients should refer to the *Workers Compensation (Medical Practitioner Fees) Order* current at the date services are delivered for further information.
